6. All decisions of the judges and rules committee will be final.

9. All registration will take place at Captain's Meeting
10. Each boat will be issued a tournament number to be prominently displayed in *port side cabin window*.
11. Should there be a tie in any cash prize category, the prize money will be DIVIDED among winners.
12. Any protest(s) must be presented in writing to the rules committee **within one hour** after weigh in to the tournament directors. Directors will serve as judges in such cases and their decision is final.
13. Management reserves the right to change, adjust, and/or cancel tournament as necessary.
